Mission

The Shoreview Human Rights Commission advises and aids the City of Shoreview by establishing and promoting a community standard of equal opportunity and freedom from discrimination. We envision a community where all people are welcomed, valued, and respected; where each person feels at home.

Purpose

The human rights commission serves in an advisory capacity to the city council. It promotes activities, education and programs that support equal opportunity, human rights and respect within Shoreview.

Duties and responsibilities include:

- A. Adopting by-laws and/or rules of conduct for its affairs.
- B. Developing, in cooperation with the State Department of Human Rights, programs of formal and informal education.
- C. Formulating human rights programs for the city, subject to review and approval by the city council. These programs shall direct and encourage the work of all individuals and agencies involved in planning, policy making and educational programming in the area of civil and human rights and shall aid citizens in bridging cultural and other differences.
- D. Coordinating efforts with the human rights commissions of neighboring cities.
- E. Making recommendations to the city manager and city council in regard to the planning or operation of any city department on issues of civil and human rights, and making recommendations regarding the adoption of such specific policies or actions as are needed to provide for full equal opportunity in the city.
- F. Advising and making recommendations to the city council in regard to human rights issues.

The commission is dedicated to ensuring Shoreview citizens have equal opportunities and rights as defined by the Minnesota Human Rights Act, Chapter 363A of the State Statutes. The act makes it illegal to discriminate in the areas of:

Goals and action plan

Awareness

Poster contest

The commission held its 30th annual poster contest, "One Community of Many Colors" in 2023. This contest commemorates Martin Luther King Jr.'s birthday. The commission received 292 student entries from the following schools:

- Emmet D. Williams
- Island Lake
- Oak Hill Montessori
- St. Odilia
- Turtle Lake

The posters were judged on:

- Expression of the theme
- Clarity of the message
- Quality of the art
- Attractiveness
- Usage of the whole sheet of paper
- Correct spelling of any text

The commission conducted presentations with the schools to present prizes to the top 10 winners and 10 honorable mention students. The 20 students were also recognized by the city council at their March 6, 2023 meeting.

Land acknowledgement statement

The commission drafted and recommended a land acknowledgement statement for city council approval this year. The city council approved the statement at their October 16 meeting. By doing so, the city recognizes and honors the Indigenous Peoples as the traditional stewards of this land.

The identity of any community is forged by the generations who have lived there in the past and present, bringing with them their cultures, beliefs, energy, and dreams. Many travel to new places in the hope of a better life, others arrive against their will, and some have been there for thousands of years.

The City of Shoreview acknowledges that our community stands on the ancestral, traditional, and current homelands of the Dakota. We also want to acknowledge the Ojibwe and other nations of people who called this place

home. The U.S. government seized Dakota and Ojibwe land in Minnesota, allowing pioneers to settle in what is now Shoreview. This land was acquired unfairly through land cession treaties. The city acknowledges the history of violence, displacement, migration, and forced re-settlement of Indigenous Peoples.

The city is aware that this land has a complex and layered history, and offers this statement as a step toward healing. Our goal is to better understand the history of the land on which Shoreview is built and the convergence of legacies that bring us to where we are today.

The city council directed the human rights commission to create and implement an action plan to accompany the statement.

Recognition days and months

The commission has identified 11 days or months for the city to recognize throughout the year. A subcommittee is now working on recommendations for how to recognize these days or months. Some ways include social media posts, proclamations, book recommendations, or sharing events.

- Black History Month (Feb)
- Lunar New Year (varies by year February 10, 2024)
- Women's History Month (March)
- Earth Day (Apr 22)
- Asian- Pacific American Heritage Month (May)
- Pride Month (June)
- Juneteenth (June 19)
- Independence Day for the USA (July 4)
- Hispanic Heritage Month (mid-Sept to mid-Oct)
- Indigenous People's Day (Oct 9th)
- Native American Heritage Month (November)

The commission also drafted a proclamation for the city council to recognize Juneteenth. The proclamation was read at the June 5 city council meeting.


Outreach

Caring youth award

Based on discussions with high school students, the commission reviewed and revised the caring youth award process this year. Changes were made to make it less intimidating for students to nominate themselves or others. Thanks to the changes, the commission received six nominations, which is the most its received since creating this award in 2012.

Mayor Sue Denkinger presented the 2023 caring youth award winner, Ellen Guo, with a plaque at the November 16, 2023 volunteer appreciation dinner. Ellen used her passion for computer science and volunteering to create a high school coding club and a middle school coding camp, where she teaches coding languages to peers and younger students.
